Want to Tutor Prospective RCMP?

The Royal Canadian Mounted Police in PEI are currently looking for tutors to assist RCMP applicants with preparation for the RPAB exam. The RPAB is a police aptitude battery test designed to evaluate an applicant's aptitude for police work. The test measures six skills that are essential to completing the duties of a police officer. These include composition, comprehension, judgment, observation, logic and computation. The RCMP is hoping to find tutors that can assist applicants in preparing for the exam. Many of our applicants have been 'out of school' for years and would benefit from a structured refresher program. A guide for tutors is presently being worked on and would be an available resource for you. Rates and scheduling would be between the tutor and the applicant.

History of the PEI RTA

Editor's note~ Joyce McCardle has over a period of time compiled a lot of information about the RTA in PEI. Much of the information has been taken from minutes of meetings. This history will be published in this and subsequent issues, in segments, as space allows. Thanks, Joyce.

PEIRTA 1975-1978

The first organizational meeting to form a PEI Retired Teachers' Association was held Oct. 22, 1975.

1975 Executive

President: Mabel Matheson Secretary: Edith Mullen

Treasurer: Ann Matheson (later re-

placed by Hollis Jenkins)

Additional Rep: Mrs. Lloyd Lewis

At this time, the PEITF president was George MacDonald, and Minister of Education was W. Bennett Campbell.

The second meeting was held Nov. 26, 1975, with Mabel Matheson as provisional president.

- A constitution was passed at this meeting. Also passed at this meeting was a resolution to request that PEITF extend the rights and privileges of a special association of the PEITF to the Retired Teachers' Association of PEI. An application form for the establishment of the PEIRTA was signed by the members present.
- In a letter dated Jan. 16, 1976, the executive acknowledged the acceptance of the RTA by PEITF as a special association of the PEITF.
- At the June 7, 1976 meeting, the guest speaker was Donalda Fraser, President of NSRTA. She

spoke about the functions and activities of their association which had been active for 10 years. I found it interesting that she stressed the fact that if we have any needs, we must be an organization of influence and act both individually and in union to get what we want.

- At the Oct. 14, 1976 meeting, the RTA went on record as recommending that the TSF Act be amended to provide that one of the teacher reps on the Superannuation Commission be a member of the RTA.
- The AGM was held Nov. 26, 1976. A new executive was installed

PEITF President was Kimball Blanchard, and Minister of Education was W. Bennett Campbell.

The AGM was held Nov. 29, 1977. The following executive was approved:

1977-1978 Executive

President: Mabel Matheson (re-elected) Vice-President: Austin Kennedy

Secretary: Frances Neal

Treasurer: Edith Mullen

Prince Co. Rep: Marjorie Dunn Queens Co. Rep: Erma Hughes Kings Co. Rep: Jocelyn Coffin The PEITF President was Willard Moase. Minister of Education was W. Bennett Campbell.

Issues of the day included the following:

- One of the main things the RTA seemed to be dealing with was trying to get an increase in retired teachers' pensions; this has been one of the association's main efforts since the organization began.
- At the PEITF AGM May 6, 1978, a motion was passed dealing with an increase to pensions. This was defeated 60-6 at the RTA general meeting held June 13, 1978. It was also passed that RTA executive press for the nearest possible proposal made by RTA.
- At the Feb. 2, 1978 executive meeting it was reported that Ron Rice had agreed to include with the pension cheques a letter from RTA. This letter would encourage all retired teachers to join the organization, while emphasizing the importance of having a strong organization.
- The AGM was held Nov. 21, 1978. It was reported that there were 204 members on the mailing list; the membership increased following the letter that was included with the cheques. The membership fee at this time was \$2.00/ year.

2015 AGM

Sheridyth chairs her last AGM



One hundred and ten members attended the 2015 AGM at the Jack Blanchard Family Centre on November 5. Several distinguished guests, among them Bethany MacLeod (PEITF President) and Hon. Hal Perry (Minister of Education and Early Learning), were absent because they were attending a press release on the dissolution of the English School Board and the introduction of a new direction for education in PEI.

Kimball Blanchard gave a report on group insurance, outlining the following points:

- •There was a small fee decrease for retirees as of October.
- •Mandatory generic substitution is a money saver for the plan.
- •Travel insurance showed a slight increase

but is still a good value.

- •If you are not 65 yet, you should check with your pharmacy about the drugs you are taking in case of a change after age 65.
- •Losses in life insurance resulted

in a rate increase for active and retired teachers.

•RTA is working on the 30-day versus 90-day prescription issue.

Dale Weldon, representing Johnson Inc. answered questions about premiums, travel insurance, generic versus non-generic drugs. He stated that new membership cards would be forthcoming early in 2016.

Membership Chair Joyce McCardle reported that there are 1553 retired teachers on PEI, 1033 of whom are members of the RTA. There were 29 new or corrected membership cards issued. Joyce is looking for ideas on how to get more retirees to join. Twenty-nine members deceased



mative presentation on long term nursing care and community care, both private and public.

James MacAulay in his ACER-CART report highlighted the three main issues being monitored by our national organization: the National Health Agreement, pensions, and Pharmacare.

Michel Plamandon, our Master Trust representative, reported that our pension fund is well diversified and is doing well considering the fluctuations of the market.

Are you approaching that critical age -65?

Drugs, Drugs

Please note that if you are turning 65 soon you should take several steps to make sure that your transition from our group coverage for prescription drugs to the province's Pharmacare coverage is as smooth as possible.

- 1) If, when you turn 65, you haven't received a new card with a new number as proof of insurance under our group plan, check with Johnson Inc.
- 2) Register for the Seniors
 Drug Cost Assistance Program (make sure your pharmacy knows you are turning 65 and will be eligible for Pharmacare).
 You will need your PEI
 Health card to register.
- 3) If you're not sure, check with your pharmacist to find out whether you have any Special Authorization drugs. If you do, you may need to reapply for cover-

- age, either under Pharmacare or under our plan.
- 4) Check with your pharmacist to find out whether a drug for which you have been getting a 90-day supply under our plan is now available for only 30 days in order to be covered by Pharmacare.
- 5) Note that your co-pay for some prescriptions may now be up to \$15.94 for each fill. If it's more, you should ask questions.

OAS

If you are going to be automatically enrolled for OAS, you should be notified by mail the month after your 64th birthday. If you haven't received a letter within six months

of turning 64, you must apply for OAS. Application forms are available from Service Canada.

Remember that when you turn 65 your teacher's pension and your CPP are integrated. Your bridge is removed; i.e., your teacher's pension will be less. If it isn't, check with Pension and Benefits at 902-368-4200. The oversight looks good initially, but you could be faced with a pay-back later.

Life Insurance Reminder

Are you approaching 65? Giving any thought to life insurance?

- At age 65 the term life insurance under the PEITF Group Insurance Plan automatically is reduced to \$15,000.
- Your coverage can be converted to a private plan with the same carrier without evidence of insurability. Apply within 31 days of turning 65.
- You may purchase an amount equal to your present coverage, or a lesser amount.
- Before your 65th birthday, so you will be prepared to make the decision that best suits your situation, you should check to find out whether you are insurable, and investigate market rates for the amount of insurance you may wish to carry.



Out-of-Province Travel Medical Insurance

Our travel insurance provides some of the best coverage in the country, but the fine print is very important. Most claim denials are because of pre-existing conditions. What follows is taken directly from our policy.

A pre-existing condition is considered Stable if you, in the 90 days before the departure date (or 90 days before the booking date for Trip Cancellation coverage*), have not:

- □ been treated or evaluated for new symptoms or related conditions;
- ☐ had symptoms that increased in frequency or severity, or examination findings indicating the condition has worsened;
- □ been prescribed a new treatment or change in treatment for the condition (generally does not include reductions in medication due to improvement in the condition, or regular changes in medication as part of an established treatment plan);
- □ been admitted to a hospital for the condition; or
- □ been awaiting new treatments or tests regarding the medical condition. (does not include routine tests).

The above criteria will be considered by Medavie Blue Cross collectively in relation to the overall medical condition.
