Executive Proposes Constitutional Changes

Editor's Note —— Below you will find the revised constitution for the PEIRTA. So that you can easily compare the current constitution with the suggested revision, existing wording has been crossed out, with new wording inserted in bold. This constitution will be discussed and approved with or without amendments at the PEIRTA Annual Meeting on November 6 at the Summerside Legion. Please bring your copy with you.

Constitution for Prince Edward Island Teachers' Association (PEIRTA)-Revised Jan/08

1. NAME

The name of the organization shall be the Retired Teachers' Association of Prince Edward Island Retired Teachers' Association.

2. OBJECTS OBJECTIVES

The objects objectives of the Association shall be:

- a) to maintain and increase professional and social contacts,
- b) to keep informed on of developments in education,
- c) to meet with government and negotiate better terms for retired teachers,
- d) to meet with outside organizations/merchants to obtain social/financial benefits for retired teachers,
- e) to maintain a liaison with the PEI Teachers' Federation,
- f) to furnish recommendations and advice to the Provincial Executive and other committees of the PEITF on matters affecting **the** welfare of retired teachers.

3. MEMBERSHIP

Active

Any teacher who was a member of the PEITF at the time of his/her retirement shall be eligible for active membership in this Association if:

- a) he/she is in receipt of a pension pursuant to the PEI Teachers' Superannuation Act, or,
- b) he/she was eligible for such pension on his/her retirement.
- c) PEITF retired professional staff in receipt of a pension pursuant to the PEI Teachers' Superannuation Act shall be eligible for membership.

Affiliate

- a) A retired teacher shall be eligible for affiliate membership in the Association if he/she is in receipt of a teacher's pension from outside Prince Edward Island PEI.
- b) PEITF retired professional staff in receipt of a pension pursuant to the PEI Teachers' Superannuation Act shall be eligible for affiliate membership.
- b) A retired teacher's spouse receiving pension pursuant to the PEI Teachers' Superannuation Act shall be eligible for affiliate membership in the Retired Teachers' Association of PEI PEIRTA.
- c) A retired teacher who held a valid PEI teaching contract at any time during his/her career shall be eligible for affiliate membership in the PEIRTA.

(Constitution, cont'd)

4. RIGHTS, PRIVILEGES AND RESPONSIBILITIES

The rights, privileges and responsibilities shall be extended as follows:

- a) To active members the full rights, privileges and responsibilities of membership.
- b) To be an executive member, a retired teacher must be a member in good standing of PEIRTA.
- c) All PEIRTA members will automatically be members of ACER-CART, the national retired teacher's organization.
- d) To affiliate members the full rights, privileges and responsibilities of membership except the right to hold office in the Retired Teacher's Association PEIRTA.

5. FEES

- a) Membership fees dues shall be established by resolution at the annual meeting of the Association.
- b) Affiliate members shall pay the same fee as members.

6. MEMBERSHIP YEAR

The membership year shall extend from the date of one annual meeting to the next annual meeting be from January 1 to December 31 of any given year.

7. EXECUTIVE

- a) The executive committee of this Association shall be: President, Vice-President, immediate Past President, Secretary, Treasurer, one additional member, and one member representative from each of the other two counties county. The members of the Executive Committee with the exception of the Past President shall be elected for a term of two years at the Annual Meeting of the Association.
- b) Members of the executive committee, with the exception of the Past President, shall be elected for a term of two years at the annual meeting of the Association and may serve a maximum of two consecutive terms.
- c) The in-coming executive committee will assume office by January 1 of the calendar year following the election.
- d) The signing authority for the PEIRTA shall be any two (2) of the President, Vice-President, Secretary or Treasurer.

8. COMMITTEES

- a) Whenever a vacancy occurs in the executive committee through any cause, the executive committee shall name a member to fill the vacancy until the next annual meeting.
- b) The executive committee shall appoint from time to time such committees as may be necessary to carry on the work of the Association.

9. ANNUAL MEETING

The Annual Meeting shall be held in October or at such other time as determined by the Executive.

- a) The annual meeting shall be held within the first seven days of November each year or at such other time as determined by the executive.
- b) The new executive will be elected every second year at the AGM.
- c) Between the AGM and January 1 of an election year, a transition meeting of the past executive and the

in-coming executive shall be held.

10. LIAISON BETWEEN THE PEIRTA AND PEITF

Any representation which the Association wishes to make to any organizations, persons, Government Department or other agency outside the Prince Edward Island Teachers' Federation shall be conducted through the regular channels of the Prince Edward Island Teachers' Federation.

- a) Minutes of PEIRTA meetings will be forwarded to PEITF.
- b) The PEIRTA shall submit a financial statement annually to the Provincial Executive of PEITF.
- c) PEITF may select a member to attend executive, special or annual meetings of the Association.

11. ANNUAL REPORT

The Association shall submit a financial statement annually to the Provincial Executive of the PEITF.

11. AMENDMENTS

After a one-month notice of motion to amend the Constitution has been given to each member, the Constitution may be amended by a 2/3 vote of the members present at any regular session of the Annual Meeting of the Association. subject to ratification by the Provincial Executive of the PEITF.

13. REPRESENTATION AT PEITF BOARD OF GOVERNORS

Upon invitation from the PEITF Executive, the Association may appoint a member or

members to attend meetings of the Board of Governors as an Associate delegate(s).

Associate delegates have the right to address the Board of Governors and speak on any

motion with the permission of the Chairman, but may not vote.)

Executive Resolutions to the 2008 Annual Meeting

- 1. Be it resolved that the Prince Edward Island Retired Teachers' Association become incorporated as a non-profit company 2 under the regulations of the province of Prince Edward Island.
- 2. Be it resolved that the present constitution of the Prince Edward Island Retired Teachers' Association, with the proposed amendments, become the bylaws of the Prince Edward Island Retired Teachers' Association Inc.
- 3. Be it resolved that the annual membership dues of the Prince

Edward Island Retired Teachers' Association be set at \$1.00/month (\$12/year).

- 4. Be it resolved that the Spring Fling be officially replaced with county socials each year.
- 5. Be it resolved that in the election year, each county representative will be nominated at the county social.
- 6. Be it resolved that the financial records of the Prince Edward Island Retired Teachers' Association be reviewed by an out-

side source selected by the executive prior to the AGM in an election year. Should a new treasurer take office in a nonelection year, this review will take place at that time.

Travel, speak French, and soak up French culture

Located in Trois-Rivières, a modern city with a 350 year history, an international French school (non-profit organization—part of the Trois-Rivières University) offers French immersion programs for elders who want to improve their French while learning about Quebec society. French language classes are offered in the mornings, while afternoons are reserved for conversation, workshops, and immersion activities in the surrounding community, such as guided visits to historical sites Les Forges du Saint-Maurice (the first

industrial community in Canada) and the Sanctuaire Notre-Dame-du Cap (the largest sanctuary to the Virgin Mary in North America), and day trips to Montreal and Québec City (celebrating its 400th anniversary this year). Participants are lodged in the university dorms and therefore have the opportunity to enjoy a typical Francophone university setting. The French immersion programs are offered in partnership with the Routes to Learning Canada non-profit organization. Every year approximately 150 elders, mostly from English

ACER-CART Report—17th AGM, Summer 2008

Representatives for the 14 retired teacher organizations from every Canadian province and the Yukon gathered at the Canadian Teachers' Federation in Ottawa on June 6-7, 2008 to share ideas, renew acquaintances, meet new friends, report on activities of the ACER-CART committees, and discuss common issues. Major issues addressed at this meeting included a revamping of the constitution and bylaws documents, clarification of the purpose of the ACER-CART Reserve Fund and the process for its utilization, and financial report formats. Johnson Inc. representatives updated the meeting on cancer care and accessibility to drug treatment, including accessibility to 24 newer cancer drugs and their public funding status across Canada. A "Best Doctors" plan was explained—an insurance plan that provides participants with quick access to a second medical opinion, when desired.

2008- 09 Elections: Helen Biales (RTO/ERO) was re-elected President, and Vaughn Wadelius Vice-President. Regional representatives are Dr. Thomas Gaskell (RTO-NSTU), Atlantic; Patricia Steele (QPARSE), Quebec; Arnold Hull (RTO/ERO), Ontario; and Wadelius (RTAM), West. While Pierre Drouin will continue as Executive Director of ACER-CART, due to other professional responsibilities he will resign as of December 31, 2008. Lynne Richard (CTF) continues in her secretarial support role for ACER-CART.

Motions were passed to pursue the following initiatives:

- Lobby the Government of Canada to establish a national pharmacare program with a national formulary; establish a national childcare program that is affordable, accountable and accessible; review and amend the Privacy Act to ensure that privacy of personal information is respected; and develop national strategies to inform seniors of their rights and available services, and to reach out to victims of elder abuse.
- Take the lead in future Pre-Budget Consultations as per ACER-CART policies.

- Develop a position paper in support of the federal government taking more responsibility for health care.
- Pursue the issue of the error in calculation of CPI by Stats Canada and request that pensioners be reimbursed accordingly; pursue the elimination of the OAS clawback and Age Credit reduction.
- Address the following issues as priorities for 2008-2009: elder abuse; availability and cost of prescription drugs; the effect of escalating property taxes on retirees.
- Establish a search committee to replace Executive Director Pierre Drouin.

Committee Reports

Pension and Retirement Income Committee (Arnold Hull, Chair)

Issues emphasized by the committee included the need for guaranteed inflation protection and COLAS for retirees; and matters related to property tax (assessments, appeals, and the role of seniors in property tax discussions).

Communications Committee (Vaughn Wadelius, Chair)

The Web site has been updated to include slide show photo presentations on AGMs since 2006; improved document information; and a revamped "What's New" page. Two editions of **OPTIONS** were produced in 2007-08, along with special e-mails, media releases, and political action updates and news alerts for directors. Contact lists for member organizations are being updated. Members were saddened by the death of our Webmaster in January. His duties were assumed by the Communications chair.

<u>Health Services and Insurance Committee</u> (<u>Thomas Gaskell, Chair</u>)

Data from the surveys on two-tier health care systems, types and costs of health plans, and drug plan make-up and costs to seniors has been reviewed. It was agreed to reaffirm current policy on health care in Canada, lobby for a national formulary/drug plan, coordinate a common front for enforcement of the core principles of the Canada Health Act, and initiate efforts for an ombudsman and trained provincial advocates for seniors.

Additional Representation - CNSO Helen Biales, our representative with the Congress of National Seniors Organizations, was requested to seek an awareness campaign by CNSO to take action against elder abuse.
