By the time RTA members read this newsletter, the weather should have turned the corner and hopefully be bringing sunshine and warmth.

Since our last newsletter, there have been some interesting and exciting events happening with PEIRTA.

In March, RTA Executive members Marg Stewart, Kimball Blanchard, Michel Plamondon, and myself met with Hon. Robert Mitchell, Minister of Health and Wellness, and Roy Cairns, Provincial Pharmacare, to discuss prescription drug issues for seniors. The biggest items discussed were the struggles seniors are experiencing with the high cost of drugs not covered, and the 30 vs. 90 day prescriptions which result in a fee of \$15.94 per drug every 30 days instead of every 90 days. A very good discussion and meeting was held. We all came away feeling that Hon. Robert and Roy were very

interested in easing drug costs for seniors. Robert made a commitment to continue to fight for a change to the days supply covered under Pharmacare. Since then there has been an election, and now we have a new minister of Health and Wellness, Hon. James Alyward, with whom we hope to set up another meeting in the fall for the discussion to be held again.

Wayne Denman (RTA Vice-President) and I attended the Preretirement seminars in Summerside (April 6) and Charlottetown (April 27) to introduce upcoming retirees to the RTA mandate and encourage them to become members upon retirement. It is so important for retirees to keep connected and be involved in continuing to advocate for seniors, especially for issues related to health and wellness.

From the Editor

Having failed to come up with anything original, I have once again turned to CARP magazine for inspiration. CARP recently released its 2018-2019 Impact Report (www.carp.ca), an annual document that looks back at accomplishments of the past year and looks ahead to what they will advocate for in the new year. One part of the report in particular caught my eye. It references the results of a number of member surveys on a range of topics. Unfortunately I haven't been able to find out details on most of the surveys: i.e. how many were surveyed, how many responded, etc. So the percentages don't mean much except, perhaps to enlighten us somewhat as to what seniors in Canada are thinking about, and prompt some thinking on our part. CARP uses these surveys to help inform their advocacy.

In the section of the report headed

"Our Members Tell Us..." the following survey results are reported (taken directly from report):

95% agree government should take steps to protect pensions when businesses go bankrupt;

1 in 3 know an older Canadian who has been abused;

88% believe the government should invest in elder abuse prevention and response;

41% are caregivers, and one-third dedicate more than 40 hours weekly to caregiving;

76% lost or had their prescription drug benefits reduced at retirement;

86% worry about their ability to access dementia supports;

90% are concerned about the time it takes to access medical specialists;

81% agree it takes too long to access diagnostic procedures like MRIs and CTs;

91% say there are not enough staff to care for residents living in long-term care.

In spite of all this, Stats Canada reported in 2018 (www.carp.ca) that seniors are more satisfied with their lives than those in younger age groups. Safety, quality of the local environment, and relationships are the domains for which they report most satisfaction. Social inclusion is given as a key factor in determining whether one lives a fulfilling life.

Music - Who Me? ~by Kimball Blanchard

Most people have had an opportunity to attend school band concerts to hear students display new found musical talents. People marvel at the fact that after only two months in grade seven the students can actually play as an ensemble and the tune is recognizable. As the students progress through the grade levels their musical talents develop to the point that by the end of grade 12 they are quite accomplished musicians. Their teachers have accomplished this with early morning practices, noon time practices, after school practices, and regular class instruction. From September to graduation in June these music teachers are involved in organizing rehearsals for concert bands and jazz bands, arranging concerts, attending band festivals, fund raising for band trips, managing instruments for all band members, and often working with as many as one third of the total school population. For many students, music helps them display their strengths, which serves to strengthen their classroom performance,

The question is what happens to these music teachers when they retire? The surprising but somehow logical answer is that they start another band. Allie McCrady and Rowen Fitzgerald were both music teachers in the public school system and made significant contributions to music education in the province. They also were active performers in various groups, including the UPEI Wind Symphony and the PEI Symphony. After retiring they got together with John MacDonald, a local musician and music patron, who

was perhaps the real driving force, along with several other interested musicians and want-to-be musicians, and they began the Second Chances Band, which is now completing its tenth season. John, Rowan, and Allie saw the need to provide an opportunity for people to begin or continue to play music in their communities.

And the community interest is obvious: the band membership generally ranges from 50 to 65. There is a seven-decade age range, as some members are just out of high school and others are in their 60s, 70s, and 80s, with one member over 90. He never misses a rehearsal. (His wife is a retired teacher and sees that he gets there on time). The age factor is never an issue as all members are united in their love of music. Retired teachers, retirees from other professions, and people from all walks of life-from students, to mechanics, to professionals—make up the group. If a person has car problems, animal issues, tax issues, health issues, educational issues, or language issues, the band has mechanics, vets, CPAs, EMTs, nurses, doctors, teachers, university professors, language consultants, and artists.

From a music perspective, the best description is that Allie and Rowan want the band to perform well, but they also know whom they are working with. Some band members had never played an instrument prior to joining the group. At the other end of the scale there are some very accomplished musicians. Between the two poles are varying levels of abilities. All that is asked of each person is to do what he/she is capable of and the conductors will live

with the results. The music chosen for performance is selected with a audience in mind but at the same time the intent is to challenge the musicians to continue to grow as players.

Retired teachers are always teachers and Allie and Rowan are great examples. Recently a UPEI music graduate joined the group in order to broaden his knowledge of the various instruments in a concert band and to gain some experience in conducting a concert band. Both regular conductors were open to this and the band members were happy to be part of his growth as a musician.

The Second Chances Band rehearses once a week on Tuesday evening at Queen Charlotte Junior High School. Having access to the school's equipment makes it possible for the band to function and the band appreciates the co-operation of the school administration and the music teacher, Sylvia Andrews, who will be joining our ranks in June. Usually two concerts a year, one in December and one in June, are held at UPEI Steele Recital Hall. As well, we join the Queen Charlotte Bands and Holland Welshman Band for various concerts.

Do you have a musical instrument that has been sitting on the shelf unused? Possibly it is time to get it down, dust it off, and join the fun in September. Some members indicated that they had not played for over thirty years, but the skills return quickly once a practice routine is established and the support of the band members is present. Intimidation is not part of the experience,

Hon. Tassi gave a quick synopsis of the Seniors' Portfolio. She outlined what has been put in place in the 2019 budget for seniors, what programs are available for seniors, and what grants are available for seniors.

Johnston's Team (Insurance) **Update**

Richard and Bob gave an informative update on the emerging trends in Auto/ Home Insurance. Particularly interesting was learning how insurance costs are negatively impacted: disasters in Canada and worldwide (storms, floods, fires, etc.), with huge claims; the rise in distracted driving and the rising cost of repairing vehicles with all of the electronics and sensors in all parts of the car. In regards to drug coverage, there are some questions about what may happen with the Pharmacare debate—what will be in the Hoskins report, what will be covered, who wins, who loses, etc. Again, watch for the Hoskin's Report and hope for the best.

•Making Retirement Income More Secure: Canadians deserve a secure


and dignified retirement, with a guaranteed and sufficient source of income.

Medicare is based on the five principles contained in the Canada Health Act: public administration, universal access, comprehensive coverage, accessibility without extra charges or discrimination, and portability across provinces.

National Seniors Strategy: Canada needs a National Seniors Strategy that optimizes health, financial security, affordable housing, and social inclusion so all Canadians can age with dignity.

REMINDER

Going forward, members of our group insurance plan will not need a doctor's referral for massage therapy or physiotherapy.

The plan covers 80% of the cost of a massage, to a maximum of \$40, for 20 treatments over 12 consecutive months.

Coverage for physiotherapy is also 80% of cost, to a maximum of \$40 per treatment, but there is no limit to the number of treatments.

Both practitioners must be licensed and certified or registered to practise.

The CIRR oversees the Reading Recovery English and French implementations in all of Canada and the Cayman Islands.

Over 5300 PEI grade 1 students have benefitted from this reading and writing individually designed intervention. Two hundred teachers have participated in Reading Recovery's professional learning and training.

Once certified, these highly trained teachers can teach anywhere in the world where RR is offered.

PEITF Travel

Insurance: Update on Pre-Existing Medical Conditions

Our out-of-province travel insurance plan has a 90-day medical stability clause. This means that if you have a pre-existing medical condition, it must be considered medically sta-ble for 90 days prior to your de-parture date if you are to be covered in the event of a medical emergency related to this condition while you are travelling.

A pre-existing condition is considered stable if the member, in the 90 days before the departure date, has not:

- 1. Been treated or evaluated for new symptoms or related conditions;
- 2. Had symptoms that increased in frequency or severity, or examination findings indicate the condition has worsened;
- 3. Been prescribed a new treatment or change in treatment for the condition.
- 4. Been admitted to a hospital for the condition; or
- 5. Been awaiting new treatments or tests regarding the medical condition (does not include routine tests).

Number 3 generally does not include reductions in medication due to improvement in a condition, or regular changes in medication as part of an established treatment plan—but each case must be reviewed individually. A change shortly before departure, for example, with a subsequent reaction, might present problems. So if you have any doubt, call Medavie Blue Cross at 1-800-667-4511, Travel Department, for clarification if you are planning to travel outside PEI..
